Early Intervention



Parents of infants and toddlers have an added tool to help them monitor their child's developmental milestones like crawling, walking, and language! In addition to regular pediatric checkups, families can also use the <u>Ages & Stages Questionnaire (ASQ)</u> online to understand how their child is developing and whether there are any developmental concerns. If developmental concerns are noted, families can engage their local early intervention program.

Dental Hygiene Spotlight



The reasons to care for your teeth go far beyond helping to keep them white and cavity free. Did you know that brushing and flossing can also help keep your heart and lungs healthy?

People with intellectual disabilities often exhibit poor oral health in part because they need to rely on providers and caregivers to assist them in maintaining good oral health habits.
