To help combat illegal dumping, the Solid Waste Management District (SWMD) is offering trail cameras for use in identifying offenders. These photos can be turned over to law enforcement for charges.

### To request the cameras:

1. **Submit Release Form:** After identifying a dumping site, get the property owner's permission and submit the release form to SWMD.
2. **Camera Placement:** SWMD will schedule a time to install the cameras at the site.
3. **Report Dumping:** Monitor the site and contact SWMD when dumping occurs, providing the date/time. We'll review the footage and provide photos to you for law enforcement.

Once charges are filed, let us know, and we'll retrieve the cameras.
