Commissioner Haley moved the adoption of the following Resolution:

**BE IT RESOLVED**, by this Board of County Commissioners to hereby execute the following contract with Clermont County Detention Center on behalf of Clinton County Juvenile Probation for bed space at a cost of \$95.00 per day/per bed effective July 1, 2017 through June 30, 2018.

**Contract for Detention Services**  
**Between the Counties of Clermont County, Ohio**  
**and**  
**Clinton County, Ohio**

This contract is entered into this 15<sup>th</sup> day of May 2017, by and between the Boards of County Commissioners of the Ohio counties of Clinton and Clermont (hereinafter referred to as the "Participating Counties") and the Juvenile Divisions of the Court of Common Pleas of the Participating Counties, through their respective judges.

Whereas, Clinton County is in the need of secure detention services for juvenile offenders, Clermont County Detention Center has such a program and is willing to provide this service to Clinton County on a contractual basis.

Whereas, and now Therefore the parties mutually agree as follows:

1. Clermont County agrees to provide and Clinton County agrees to pay if space is available, a per diem of \$95.00 per day/per bed.
2. The parties agree the term of said Agreement shall be from July 1, 2017 through June 30, 2018, and with the right to extend this Agreement on an annual basis. The parties further agree that the per diem bed costs shall be renegotiated and calculated annually, based upon the operational costs and the per diem bed costs shall be established on or before March 1<sup>st</sup> of each calendar year.
3. The parties herein acknowledge that admissions of juvenile(s) into said Detention Center must be made pursuant to the provisions of Rule 7 of the Ohio Rules of Juvenile Procedure and said juvenile(s) and the admitting Court must comply with all admissions criteria of the Detention Center and support the same appropriate documentation.
4. The parties agree that all expenses for any medical, dental, counseling, or any other extraordinary costs which are not provided by the Detention Center as part of the routine services provided shall be paid for by the juvenile's parent/guardian/custodian, their insurance provider or lastly, the Court which placed said juvenile at the Detention Center.
5. Clermont County shall prepare a monthly invoice for Clinton County and provide details of attendance with that invoice for the services provided by this Agreement. The payment is to be made from Clinton County in full within thirty (30) days from the date of the invoice. The failure of Clinton County to make timely payments pursuant to this Agreement may result in a suspension or termination of this Agreement and the services provided herein. The payment shall be made payable to Clermont County Juvenile Court and mailed to Clermont County Juvenile Court, 2340 Clermont Center Drive, Suite 100, Batavia, Ohio, 45103.
6. The parties to this Agreement acknowledge that all juveniles detained at the Detention Center will be required to participate in the programs provided at said Detention Center.
7. The parties acknowledge and agree that Clermont County shall provide the educational requirements for all juveniles in the Detention Center and shall prepare and submit invoices for the same to the juvenile's home school district. Clinton County agrees to provide appropriate orders to identify each child's home school district and to establish their responsibility for payment of said child's education.

8. The parties agree that any modification or amendments to this Agreement must be agreed to, in writing, by both parties.
9. The Parties agree that the terms recited herein are the entire Agreement.
